POLICY STATEMENT

: To ensure the efficient use of funds directed by Council to be used for the purpose of future funding of projects, ensure services levels are maintained and not immediately impacted by any unforeseen circumstances.

Operating reserves are established to fund extraordinary projects, minimize revenue fluctuations and stabilize property tax rate increases. Capital reserves are established to apportion costs of tangible capital assets over their useful lives and to assist in long range financial planning.

PURPOSE

To define and delineate how reserves are created, closed, administered and reviewed.

GUIDELINES/PROCEDURES/RESPONSIBILITIES:

Approval

- 1. Approval for the establishment and transfers to and from reserves shall be through the annual Council budget approval process or through resolution or bylaw.
- 2. All reserves shall be identified as follows:
 - a. Name
 - b. Type (Operating or Capital)
 - c. Purpose
 - d. Source of funding
 - e. Maximum balance
 - f. Interest bearing
 - g. Duration

Administering Reserves

- 1. Administration of reserves shall be the responsibility of the Chief Administrative Officer or designate
- Administration shall manage a reserve in accordance with the reserve's purpose and any or all conditions and/or restrictions placed upon the reserve by Council. Reserves administration activities shall be undertaken throughout the year in accordance with the applicable administration policies.
- 3. Revenue sources for reserves and expenditures from reserves are to be budgeted for in departmental budget programs.
- 4. Transfers to and from reserves shall be restricted as follows:
 - a. Amounts established through annual budget process

- b. Allocations from annual operating surpluses or accumulated unrestricted surplus funds as approved by Council
- c. Cash receipts such as tangible capital asset sales, land sales, fees collected through the land development process or other receipts approved by Council
- d. Interest income earned on reserves as directed through legislation or policy
- e. Special consideration as approved by resolution or bylaw
- f. Funds carried over to a subsequent year to fund specific programs and projects not completed prior to the current year end.
- 5. Reserve reporting to Council shall be as follows:
 - a. Annual budget review identifying proposed transfers in and out of reserves
 - b. Annual Financial Statement as a note disclosing a list of accounts and balances at the end of the applicable year
