- **POLICY STATEMENT :** The Town of Westlock recognizes there are circumstances where Community Peace Officers may need to use a defensive baton to facilitate a defensive position in the execution of their duties.
- **PURPOSE** : The Town Manager is authorized to approve the carrying and use of defensive baton by Community Peace Officers.

## **GUIDELINES / PROCEDURES / RESPONSIBILITIES:**

### 1.0 QUALIFICATIONS

- **1.0** The issue of defensive baton to a Community Peace Officer is condition upon;
  - a) Authorization of their Appointment as issued by the Alberta Solicitor General.
  - **b)** Successful completion of a training course on a use of force model recognized by the Public Security Division.
  - c) The Community Peace Officer being certified and/or recertified in the use of the defensive baton by a qualified instructor.

#### 2.0 APPROVED USES

- a) The defensive baton must only be used as a defensive tool and should not be applied to facilitate an arrest unless other means are not available.
- b) A defensive baton may be utilized to control an attack or threat of an attack from any animals.

#### 3.0 **PROCEDURES**

- a) The defensive baton issued to a Community Peace Officer shall be a style that utilizes centrifugal force.
- b) The defensive baton must be worn in the issue scabbard.

- c) Community Peace Officers who are carrying authorized batons:
  - i. Must check their baton on a weekly basis for the following;
    - a) Wear and tear on the foam grip
    - b) Bent shaft and stress fractures
    - c) Abrasions on the tip or a loose tip
    - d) Secure butt cap.
- d) May make minor adjustments to the retaining clip and O-ring to ensure the proper opening and closing capabilities.
- e) Report a defective baton requiring repair or replacement to the Supervisor.
- f) Ensure that when off-duty, the baton is secured in a locked cabinet within the office. If a Community Peace Officer goes off shift at their resident, the defensive baton must be secured within a locked cabinet.
- e) Community Peace Officer shall only use the defensive baton which is supplied by the Town of Westlock and issued by the Supervisor.

#### 4.0 REPORT ON USE

- **4.1** A Community Peace Officer involved in a an occurrence where a defensive baton was utilized by either himself or another Community Peace Officer must;
  - a) Complete a standard incident report outlining the circumstance surrounding the use of the defensive baton and provide a copy of the report to the Supervisor and the Solicitor General Public Security.
- **4.2** The Supervisor shall notify the Town Manager in writing, of the circumstance surround the use of a defensive baton.
