WHEREAS, pursuant to the *Municipal Government Act*; Chapter M-26, R.S.A. 2000 and amendments thereto, the Council may pass a Bylaw for the purposes of providing goods services by or on behalf of the municipality:

And WHEREAS, pursuant to the *Municipal Government Act*; Chapter M-26, R.S.A. 2000 and amendments thereto, the Council may pass a Bylaw for establishment of fees for licenses, permits and approvals as established by Council;

And WHEREAS, pursuant to the *Freedom of Information and Protection of Privacy Act*, Chapter F-12, R.S.A. 2000 and amendments thereto, a municipality must make certain information available to the public and may by bylaw establish for providing information;

And WHEREAS, the Town of Westlock Council deems it appropriate to establish fees and rates.

NOW THEREFORE, the Town of Westlock Council enacts as follows:

- 1. This Bylaw may be cited as the Fees and Rates Bylaw.
- 2. The fees and rates for the Town are established as shown in "Schedule A' of this Bylaw.
- **3.** That Council may consider setting or permitting fees or rates for special circumstances, special items, individual agreements with outside parties or for any item not established in "Schedule A" by resolution of Council.
- **4.** That Bylaw 2016-09, Fees and Rates is hereby repealed.
- **5.** This Bylaw shall take full force and effect upon third and final reading.

Records Management

Fees may be required for services provided to an applicant under the FOIP Act.

Fees may be assessed for:

Locating, retrieving and producing the record;

Computer and programming time for producing electronic records; preparing the record for disclosure;

Copy records for release;

Supervising the inspection of records; and

Shipping.

Processing of a request will not commence until the initial fee has been paid.

An applicant is required to pay:

- a) An initial fee of \$25 when a non-continuing request I made; or
- b) An initial fee of \$50 when a continuing request is made.

In addition to the initial fee, fees in accordance with this Schedule may be charged if the amount of the fees, as estimated by the public body to which the request has been made, exceeds \$150.

Where the amount estimated exceeds \$150, the total amount is to be charged.

A fee may not be charged for the time spent in reviewing a record.

Records Management Cont.

Fees for Personal Information

This section applicant to a request for access to a record that is a record of the personal information of the applicant.

Only fees for producing a copy of a record in accordance with items 3 to 6 of this Schedule may be charged if the amount of the fees as estimated by the public body to which the request has been made exceeds \$10.00.

Where the amount estimated exceeds \$10.00, the total amount is to be charged.

The amount of the fees set out in this Schedule are the maximum amounts that can be charged to applicants.

- 1) For searching for, locating and retrieving a record \$6.75 per ¼ hr
- 2) For producing a record from an electronic record:
 - a. Computer processing and related charges actual cost to public body
 - b. Computer programming actual cost to public body up to \$20.00 per ¼ hr
- 3) For producing a paper copy of a record:
 - a. Photocopies and computer printouts:
 - i. Black and white up to 8.5" x 14" \$0.25 per page
 - ii. Other formats \$0.50 per page
 - iii. From microfiche or microfilm \$0.50 per page
 - iv. Plans and blueprints actual cost to public body
- 4) For producing a copy of a record by duplication of the following media:
 - a. Microfiche and microfilm actual cost to public body
 - b. Computer disks \$5.00 per disk
 - c. Computer tapes actual cost to public body
 - d. Slides \$2.00 per slide
 - e. Audio and video tapes actual cost to public body
- 5) For producing a photographic copy (colour or block and white) printed on photographic paper from a negative, slide or digital image:
 - a. 4" x 6" \$3.00
 - b. 5" x 7" \$6.00
 - c. 8" x 10" \$10.00
 - d. 11" x 14" \$20.00
 - e. 16" x 20" \$30.00

Records Management Cont.

- 6) For producing a copy of a record by any process or in any medium or format not listed in sections 3-5 above actual cost to public body
- 7) For preparing and handling a record for disclosure \$6.75 per ¼ hr
- 8) For supervising the examination or a record \$6.75 per ¼ hr
- 9) For shipping a record or a copy of a record actual cost to public body

Remedial Work

- 1) This section shall apply to any Enforcement Order/Stop Order issued under Section 545, 546, 645, or work done pursuant to any section under Par 13 Division 5 of the *Municipal Government Act*.
- 2) All costs of work provided by the Town pursuant to this section, whether provided directly by the Town or by a Contracted Service, shall be subject to a 20% administration fee in addition to the cost of work provided (actual costs, Taxed).
