## **Cancellation / Refund Policy**

Any Person acquiring a Plot(s) under the provision of this Agreement shall only acquire the right and the privilege of burial of the dead therein subject to the provision of Bylaw 2012-04 and shall not be deemed to acquire any title to the land which shall remain vested in the name of the Town.

**Cancellation** of a contract can be requested at any time for any reason. You may cancel without charge or penalty at any time during the period from the day you enter into the contract until 30 days after you receive a copy of the contract. Contracts cannot be cancelled for pre purchased niches that have had inscriptions completed. If you cancel after 30 days you may still have to pay for interment space and for any cemetery supplies and or services that have already been supplied, performed, or delivered as the case may be.

**To cancel**, you must give notice of cancellation to the Town of Westlock at the address shown in this agreement. You should give notice of cancellation by a method that will allow you to prove that you gave notice, such as registered mail, fax, courier or by personal delivery.

**Refunds**, the Town of Westlock does not allow the resale of interment space on the open market. Plots shall not be resold, transferred or disposed of any manner, except by transfer back to the Town at purchase price less a transfer fee as set out in Bylaw 2012-04. No transfer shall be valid unless it is duly registered with the Town.

As a seller who does not allow the resale of plots on the open market it is legislated that the Town must buy back the unused interment space. If the cancellation is requested during the 30 day cancellation period, then a full refund will be issued. Once this period is over, a refund of the purchase price less \$50.00 per plot will be issued.

Within thirty days of receiving notice The Town will refund fees at no interest, paid to the purchaser.
